Subject: PCN# 01A-24 Notification of Lattice Product Import / Export Classification Change

Dear Lattice Customer,

Lattice Semiconductor will be changing its product import / export classification.

Change Description

Lattice Semiconductor Corp. and its affiliates (“Lattice”) regularly reviews its product import / export classifications to align with changes published by relevant jurisdictions. Due to recent updates from the U.S. Census Bureau and U.S. Customs and Border Protection, Lattice is providing this notification to inform you of the following Lattice product import / export classification changes.

Affected Devices

Appendix -Frequently Asked Questions (FAQs)

Q: What is Lattice announcing?

A: We are updating the Schedule B and HTS codes for our products affected by the recent change from the US agencies and will adopt the new classifications effective February 19, 2024. The change will affect all Lattice programmable logic products.

Q: Why is the US government making this change?

A: US agencies conduct an annual review of the Schedule B and HTS codes to align itself with recommendations from the World Customs Organization, as well as to insert new products that have entered the market and remove obsolete ones.

Q: Where can I find more information about the change?

A: You can refer to the US Census Bureau website and download the summary of Schedule B changes (https://www.census.gov/foreign-trade/schedules/b/2024/jan_obsoletetnew.pdf). The latest Schedule B and HTS 2024 versions can also be downloaded from the respective US agencies.

Q: Does this affect the export control status of Lattice products?

A: No. The Export Control Classification Number (ECCN) of Lattice products is not affected by this update.

Q: What is Lattice doing to comply with this change?

A: Lattice is updating its internal systems to reflect the new classifications, while at the same time, proactively reaching out to inform our stakeholders. As effecting system changes will require some preparation and time, Lattice has decided to fully adopt the new classifications starting from February 19, 2024.

Q: What does my company need to do to comply with this change?

A: Please consult your internal Legal/Trade organizations for the actions that you need to take to comply.

Q: What is the impact on our current process with Lattice?

A: If you are importing Lattice products, you will see the new classifications reflected in the Lattice shipping documents. If you are exporting Lattice products to end-customers, or returning Lattice products under RMA, we highly recommend that you follow and use the new classifications in your shipping documents to ensure compliance with the updated codes. Note that we will not approve the RMA returns if the old codes are still used after the implementation date.

Q: Does this affect Lattice application/development/evaluation boards?

A: No. The change only affects our programmable integrated circuit devices.

Q: Does this impact existing import and export licenses that my company has?

A: Please consult your internal Legal/Trade organizations to determine if and how your company will be impacted.
